# TESTIMONY of SOCIALISM – EXECUTIVE ORDER 13603 and SLAVERY in AMERICA

Peasants in those days had an extremely hard life. It could be literally compared to a life of a slave, who didn't know how to brake up that vicious circle of working too hard at a collective farm to earn nothing even a penny a day and paying tremendous taxes for all things they had.

A family of any number of members could have only one acre of land and not any more. They didn't allow neither rent the land nor use it above that limit. Some families had some 14 to 17 children, but the same law was in force for every family unit: pay taxes not only for the land in size of an acre, but also pay for each tree bearing fruit irrespectfully if it does this year or not. That's why most of the people cut down their apple trees, pear trees, plumb trees and cherry trees.

Only one cow was allowed to be kept on a property and it was unbearably taxed as well as sheep, goats, beehives and all other animals. There was not allowed for a single family in the USSR to own a horse since 1929 for several decades. If someone had one for a short time, then thehorse was confiscated and the owner could be either fined a great sum of money or even exiled to Siberia. All teenagers aged 14 (at the time of WWII at the age 10) and on should work daily at a collective farm for 10 to 12 hours for free. There was neither any peasant who was paid for that work nor did get any pension either. While a person could walk he or she should go to work irrespectully of health problems or any age limits.

The chairman or a team leader would put a special mark like a stick against a surname of a person who worked that dayin a job employee book. If someone didn't get 26 or so sticks a month – he or she is in a real trouble. In such a case they could take away a trunk with clothes or a cow and the family would starve to death. A lot of million of peasants and their families were killed like that or in similar circumstances, when someone had more food, then someone else and all things were taken away to make everyone equal. Real lawlessness was in every sphere of life. Most of the people were like animals not having any rights at all.

My mother Alexandra lived in a village for 33 years and had a desire to drink a cup of milk or to eat a piece of grain bread. If she used to drink watery milk – it was 90% water. Bread they made had only 20% grain at the very most. All the rest was

 unpeeled potatoes, acorns, sweet beet roots or something similar and wild herbs.

Overwhelming taxes didn't give my mother even a little chance to sleep more then 2 or 3 hours a night. She had to make clothes for people who could pay some money and she tried to cover the due taxes. My grand mother used to see her daughter Alexandra dozing in front of the sawing machine at 3 a.m. and she has to be up at least at 5 or even earlier, to milk a cow, feed the animals and go to work.

In those days peasants produced everything – all kind of clothes, sandals, wool high boots and things for the house themselves. Out of harvest season they could buy a pound of salt and that was it during a month or so. Almost all year round except for winter time most of the people wore lime bark sandals, which they had to make themselves as well. It used to take several weeks to produce a pair because the bark should be treated in water to be flexible and then properly dried up.

Executive Order -- National Defense Resources Preparedness

## Section 103

- (a) identify requirements for the full spectrum of emergencies, including essential military and civilian demand;
- (b) assess on an ongoing basis the capability of the domestic industrial and technological base to satisfy requirements in peacetime and times of national emergency, specifically evaluating the availability of the most critical resource and production sources, including subcontractors and suppliers, materials, skilled labor, and professional and technical personnel;

# **Slave Labor Force**

Sec. 502. Consultants. The head of each agency otherwise delegated functions under this order is delegated the authority of the President under sections 710(b) and (c) of the Act, 50 U.S.C. App. 2160(b), (c), to employ persons of outstanding experience and ability without compensation and to employ experts, consultants, or organizations. The authority delegated by this section may not be redelegated.

Sec. 601. Secretary of Labor. (a) The Secretary of Labor, in coordination with the Secretary of Defense and the heads of other agencies, as deemed appropriate by the Secretary of Labor, shall:

- (1) collect and maintain data necessary to make a continuing appraisal of the Nation's workforce needs for purposes of national defense;
- (2) upon request by the Director of Selective Service, and in coordination with the Secretary of Defense, assist the Director of Selective Service in development of policies regulating the induction and deferment of persons for duty in the armed services;
- (3) upon request from the head of an agency with authority under this order, consult with that agency with respect to: (i) the effect of contemplated actions on labor demand and utilization; (ii) the relation of labor demand to materials and facilities requirements; and (iii) such other matters as will assist in making the exercise of priority and allocations functions consistent with effective utilization and distribution of labor;
- (4) upon request from the head of an agency with authority under this order: (i) formulate plans, programs, and policies for meeting the labor requirements of actions to be taken for national defense purposes; and
- (ii) estimate training needs to help address national defense requirements and promote necessary and appropriate training programs.

## Section 801:

Farm Equipment, Energy, Food, Civil transportation, Food resources, Food resource facilities
